Jubasan, Allen, N. Samar represented herein by **CARLO C. PALACIO** duly authorized for this purpose, hereinafter referred to as the "**CONTRACTOR**";

In consideration for the sum of Nine Million Seven Hundred Forty Nine Thousand Eight Hundred Eighty Five Pesos and Ninety Two Centavos Only (Php 9,749,885.92) or such other sum as may be ascertained, [C. A. CONSTRUCTION & SUPPLY] agrees to [Construction of Road, Sitio Crystal Mountain, Barangay San Jose, Mondragon, Northern Samar] in accordance with his/her/its Bid.

- 3. The **Department of Public Works and Highways (DPWH)** agrees to pay the above-mentioned sum in the day and year first before written.

A slippage of more than thirty (30) days in the original schedule would result in non-payment, the cancellation of the contract, blacklisting of the erring contractor, and the entry of a new contractor who will finish the project.
