**CONTRACT AGREEMENT**

**KNOW ALL MEN BY THESE PRESENTS:**

This CONTRACT AGREEMENT, made this JUL 01 2025 between DPWH, Tacloban City District Engineering Office with main office address at New Bus Terminal, Brgy. Abucay, Tacloban City (hereinafter called "ENTITY") and CDU CONSTRUCTION with main office address Magsaysay, Bobon, Northern Samar (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute Contract ID No. 25IM0065 – Rehabilitation of Road with Drainage Structure, Barangay 83-C, Tacloban City (hereinafter called "the Works") and the Entity has accepted the Bid for Four Million Eight Hundred Ninety-Seven Thousand Five Hundred Pesos Only (P4,897,500.00) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this CONTRACT AGREEMENT, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

In consideration for the sum of Four Million Eight Hundred Ninety-Seven Thousand Five Hundred Pesos Only (P4,897,500.00) or such other sums as may be ascertained, CDU CONSTRUCTION agrees to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract Agreement in all respects in accordance to his Bid.

4. The DPWH, Tacloban City District Engineering Office agrees to pay the aboved-mentioned sum in accordance with the terms of Bidding.
