WHEREAS, the DPWH-Cagayan 3rd District Engineering Office advertised/posted the Invitation to Bid for the above-stated project on March 06, 2025 at the DPWH and PhilGEPS website and at a conspicuous place within the premises of the DPWH-CTDEO for seven (7) calendar days;

WHEREAS, in response to the said Invitation, two (2) interested bidders purchased bidding documents from March 06, 2025 until the deadline for the submission of bids, to wit:

- 1. COLORSHIELD CONSTRUCTION AND DEVELOPMENT CORPORATION
- 2. 5MJ'S CONSTRUCTION

WHEREAS, the prospective bidders, COLORSHIELD CONSTRUCTION AND DEVELOPMENT CORPORATION and 5MJ'S CONSTRUCTION, submitted their respective bids on March 25, 2025 on the prescribed place and time;

WHEREAS, during the Bid Opening, the BAC through the Secretariat read the generated result of Contractor's Electronic Eligibility screening using the DPWH Civil Works Application (CWA) to check the bidders' compliance as to legal, financial, and technical capabilities, simultaneously, preliminary examination was conducted on the technical envelopes of the two (2) bidders, using a non-discretionary "pass/fail" criterion (presence or absence of required documents) against the checklist of requirements as stipulated in the bidding documents;

WHEREAS, the BAC thru the TWG found out that COLORSHIELD CONSTRUCTION AND DEVELOPMENT CORPORATION attached its updated BIR Tax Clearance with Audited Financial Statements stamped "Received" by the Bureau of Internal Revenue (BIR), and 5MJ'S CONSTRUCTION which also attached its updated PCAB License Certificate, in their respective technical envelopes, thus, the BAC rated both bidders "passed" in the preliminary examination, and proceeded with the opening of their financial bids, however, the said bidders were subjected for Unlocking in the Civil Works Application (CWA). WHEREAS, after the opening and preliminary evaluation of bids, the BAC informed the bidders that their bids shall be subjected to bid evaluation and post qualification as required in the 2016 Revised IRR of R.A. 9184;

WHEREAS, the BAC forwarded updated certified true copies of COLORSHIELD CONSTRUCTION AND DEVELOPMENT CORPORATION'S, BIR Tax Clearance, stamped "Received" by the Bureau of Internal Revenue (BIR) on its Audited Financial Statements, and 5MJ'S CONSTRUCTION'S updated PCAB License Certificate, including their PhilGEPS Registration Certificate, to the Procurement Service, DPWH-Central Office for updating, and a Request for Unlocking at CWA, in order for the BAC to reprocess the eligibilities of the said bidders;

WHEREAS, the BAC, with the assistance of its Technical Working Group, conducted the detailed evaluation of the above-mentioned bids on <u>March 27, 2025</u> which resulted in the following bid as calculated:

WHEREAS, after the bid evaluation conducted by the TWG and as presented to the BAC, the result showed that COLORSHIELD CONSTRUCTION AND DEVELOPMENT CORPORATION and 5MJ'S CONSTRUCTION, were found compliant to the requirements of the financial envelope, hence, recommended as complying;

WHEREAS, on April 23, 2025, the BAC received the approval of the request for unlocking thru email (outlook). The BAC thru the BAC-Secretariat conducted the re-processing of the eligibility check for COLORSHIELD CONSTRUCTION AND DEVELOPMENT CORPORATION and 5MJ'S CONSTRUCTION, wherein both bidders were found eligible;

WHEREAS, the TWG completed the post-qualification to the Lowest Calculated Responsive Bidder, COLORSHIELD CONSTRUCTION AND DEVELOPMENT CORPORATION. Result showed that the bidder has satisfied the legal, technical and financial requirements of the Bidding Documents, hence, the BAC found its bid responsive and, therefore, the bidder is post-qualified;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) declare COLORSHIELD CONSTRUCTION AND DEVELOPMENT CORPORATION, the Bidder with the Lowest Calculated Responsive Bid (LCRB) for the above Contract; and
- b) To recommend to the **District Engineer** for approval the award of the said Contract to COLORSHIELD CONSTRUCTION AND DEVELOPMENT CORPORATION the Lowest Calculated Responsive Bid (LCRB) at its total submitted bid or total Calculated Bid, whichever is lower, in the amount of SIX MILLION SEVEN HUNDRED NINETY ONE THOUSAND THREE HUNDRED ONE PESOS AND 75/100 (P6,791,301.75).
