WHEREAS, the Approved Budget for the Contract (ABC) is in the amount of **PhP 4,455,000.00**;

WHEREAS, before opening the bids, the BAC-Technical Working Group (TWG) conducted the electronic eligibility check of the bidders through the DPWH Civil Works Application (CWA), the results generated of which deemed **the bidder eligible** to participate the bidding for the said Contract;

WHEREAS, using the non-discretionary "pass-fail" criteria, the bidder passed during the preliminary examination of technical and financial components of the bidding documents;

WHEREAS, the amount of bid of the eligible bidder's as read is as follows:


