**WHEREAS**, before opening the bid, the BAC-Technical Working Group (TWG) conducted the electronic eligibility check of the bidders through the DPWH Civil Works Application (CWA), the results generated of which deemed **the bidder eligible** to participate the bidding for the said Contract;

**WHEREAS**, using the non-discretionary "pass-fail" criteria, the bidder passed during the preliminary examination of technical and financial components of the bidding documents;




