**WHEREAS**, the **Department of Public Works and Highways, Iloilo 6<sup>th</sup> District Engineering Office, Balabag, Dumangas, Iloilo**, advertised the Invitation to Bid for the above-stated Contract and posted the same at the websites of the DPWH, PhilGEPS and in a conspicuous place at the premises of the **DPWH - Iloilo 6<sup>th</sup> District Engineering Office, Balabag, Dumangas, Iloilo** continuously for seven (7) days starting on March 22, 2025;

**WHEREAS**, in response to the said Invitation to Bid, the BAC received seven (7) bid before the deadline of submission of bids for the said Contract on April 14, 2025, at 10:00 A.M.;

**WHEREAS**, the Approved Budget for the Contract (ABC) is in the amount of **PhP 47,767,500.00**;

**WHEREAS**, before opening the bids, the BAC-Secretariat (TWG) conducted the electronic eligibility check of the bidder through the DPWH Civil Works Application (CWA), the results generated of which deemed the **seven (7) bidder eligible** to participate the bidding for the said Contract;

**WHEREAS**, using the non-discretionary "pass-fail" criteria, the bidder passed during the preliminary examination of technical and financial components of the bidding documents;

**WHEREAS**, the amounts of bids of the eligible bidder as read is as follows:

**WHEREAS**, upon post-qualification, validation & verification of the eligibility, technical & financial documents submitted by the Bidder with the Lowest Calculated Bid, MBM CONSTRUCTION, the BAC found its bid non-responsive and, therefore, the bidder is post-disqualified through a Resolution No. 72, Series of 2025, dated May 28, 2025. The second-lowest calculated bid is therefore post-qualified.

**WHEREAS**, upon post-qualification, validation & verification of the eligibility, technical & financial documents submitted by the Bidder with the 2nd Lowest Calculated Bid, **KIRSKAT VENTURE**, the BAC found its bid responsive and, therefore, the bidder is post-qualified and its Bid should be declared the Lowest Calculated Responsive Bid;

**NOW, THEREFORE**, we the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **KIRSKAT VENTURE**, as the Bidder with the Lowest Calculated and Responsive Bid (LCRB) for the abovementioned Contract, and;


