He further asked if that will be the volume of the materials.*
- *Engr. Valiente confirmed that this would be the volume of the materials.*
- *Engr. Piape asked what was inside it.*
- *Engr. Valiente responded that it was sand.*
- *Engr. Piape asked if it was a separate item or it was included in one item. He also asked for the item number used for this.*
- *Engr. Valiente responded that it was item 715 (2). He also stated that the item for the Separation Geotextile was already in the DUA.*
- *Engr. Capila, BAC Member, asked if one tube will be continuous from beginning to the end portion.*

- *Engr. Valiente expressed that for this, he made it four meters.*
- *Engr. Piape asked if they will not violate any rules during the design audit if they will remove the net and only use rocks. He also asked what really was the function of the net and why it was placed in the middle. Later, he stated that there was still time to make revisions for this. Then, he asked if the site was accessible for the equipment.*
- *Engr. Valiente confirmed that it can be accessed.*
- *Engr. Piape asked if he was sure about it.*
- *Engr. Valiente responded that there was an access road.*
- *Engr. Piape asked where they got the term geotube and why it was included in the project.*

- *Engr. Arguillas, Planning and Design Section representative, informed the BAC that the thickness should be 0.20, and he was not able to edit this in the plan. He assured the*

BAC that he will correct and edit this. Later, he informed the BAC that he has a copy of the Barangay Certification for the right-of-way, and based on their cost estimate audit, they were required to have a waste disposal, since the volume for this was only small. He stated that they have talked with the Barangay, and the waste of the item 102 can be placed at the existing road of the Barangay, since there were portions with holes. He suggested that during the project implementation, the contractor should coordinate with the Barangay Captain, since there might be other site where they can use as waste disposal. He also informed the BAC, if ever they wondered why it will exceed, that there was an existing pavement which has a width of 4 meters only at the beginning portion of this, but the proposed pavement was 2.5 (5). He added that the end portion of this will not be even

- Engr. Piape asked if the distance from the site towards the waste disposal area was already determined.
- Engr. Arguillas confirmed that it was already determined.
- Engr. Piape expressed that they have to consider the costing of the fuel.
- Engr. Arguillas responded that the road identified by the Barangay Captain, if he was not mistaken, was still the same road going to Songkoy, which was more than one kilometer, but it will not reach 3 kilometers.
- Engr. Piape expressed that at least it would be compensated. Then, he asked for the minimum requirement
- Engr. Arguillas responded that it would be at least three kilometers.
- Engr. Dapar added that if it will exceed three kilometers, there would be payment needed.
- Engr. Piape asked about the volume, and if there was a need to bring it there if the volume was only minimal. He advised Engr. Arguillas that the required minimum volume for waste disposal should be determined, since it was a requirement. Later, he asked for the volume of the surplus.
- Engr. Arguillas responded that it was 451 or 40 hauling which was 10 cubic each. He shared that during their last site visit for geotagging, the Barangay Captain has told him that there were many areas that can be placed (with the surplus) as long as it was coordinated with the Barangay Captain.
- Mr. Mark Basil, representative of C.V. Construction & Development, asked if the location of the disposal will be the same area.
- Engr. Arguillas confirmed that it will be the same. He stated that this should be coordinated with the Barangay LGU on where the waste will be disposed.
- Engr. Dapar stated that it should be mentioned during the pre-construction meeting that it would be free haul if it will be within three kilometers.
- Engr. Arguillas agreed that it should be mentioned during the pre-construction meeting.
- Engr. Capila asked about the right-of-way.
- Engr. Arguillas responded that it was an existing barangay road, and there were portions wherein the sides has also an existing canal but there were also portions where there was no canal because there was a cliff area. He also mentioned that there was a cliff portion on the left side.

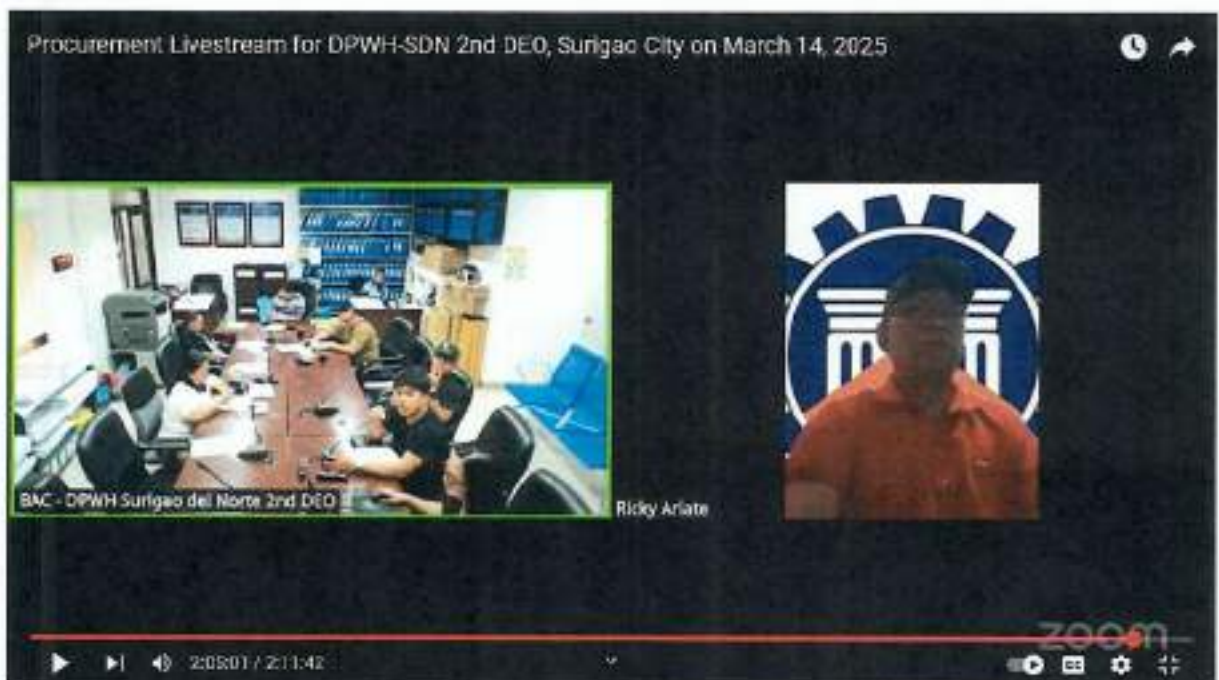
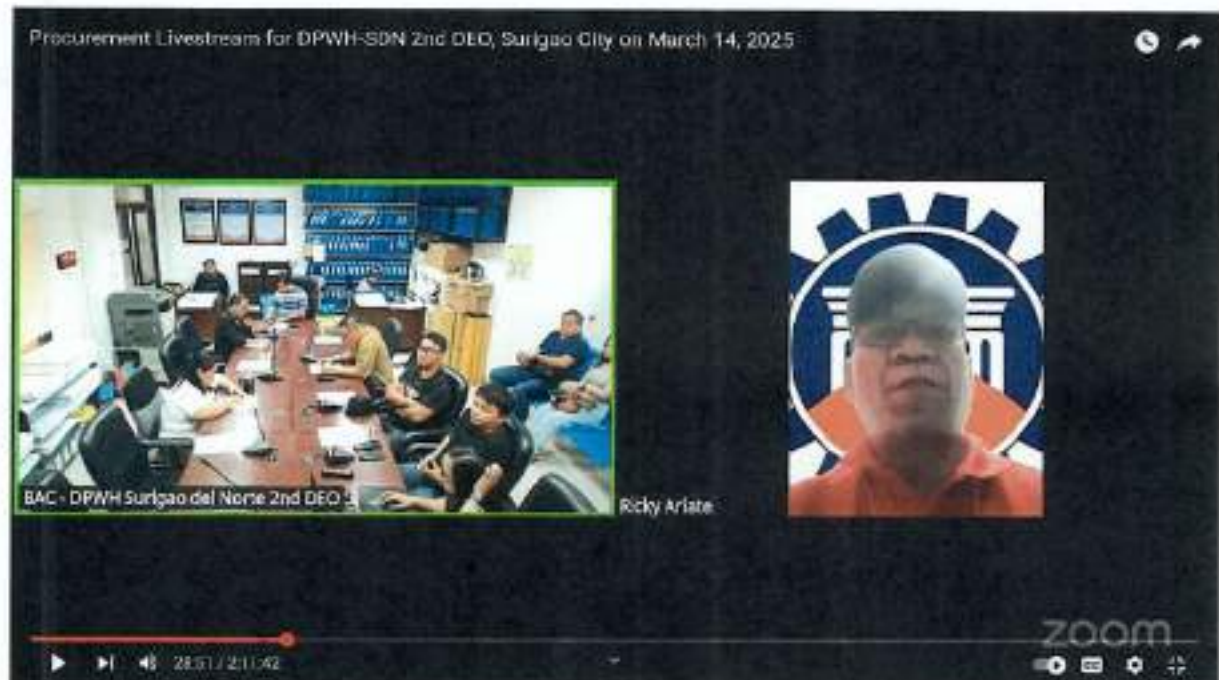
