BAC RESOLUTION GRANTING THE MOTION FOR RECONSIDERATION OF LAGRIMAS CONSTRUCTION AND CONSULTANCY AND REQUESTING THE UNLOCKING OF PROJECT ID 25FF0047 IN THE CIVIL WORKS APPLICATION

WHEREAS, on May 28, 2025, the DPWH Camarines Sur 3rd District Engineering Office Bids and Awards Committee conducted the public bidding as per duly published Invitation to Apply for Eligibility and to Bid for the following projects:

 Contract ID No. 25FF0047 – Construction of Multi-purpose building (Covered Court) Barangay San Antonio Quipayo Calabanga Camarines Sur

WHEREAS, during the opening of bids for CID No. **25FF0047**, among the bidders who tendered their respective bids are **LAGRIMAS CONSTRUCTION AND CONSULTANCY** and **ST. BERNARDINE CONSTRUCTION & ENTERPRISES**;

WHEREAS, during the Eligibility Check, Lagrimas Construction and Consultancy was disqualified due to the absence of an updated Audited Financial Statement reflected in the DPWH Contractor's Profile, which is a requirement under the civil works application eligibility criteria;

WHEREAS, on the same day, the firm submitted a Motion for Reconsideration, citing that their updated Audited Financial Statement had already been prepared and submitted, but was not yet reflected in the DPWH online system due to unforeseen delays, and they have since taken steps to ensure compliance;

WHEREAS, upon verification and careful evaluation of the submitted documents, including the updated DPWH Contractor's Profile and 2023–2024 Audited Financial Statement and Philgeps Certificate, the BAC finds that the deficiency was procedural and not substantive, and the firm has now complied with the necessary eligibility requirement;

WHEREAS, the BAC acknowledges that the non-reflection of the updated financial statement was beyond the control of the firm and has since been remedied;

NOW THEREFORE, on motion duly seconded and after due deliberation, the Bids and Awards Committee RESOLVES as follows:

- a. TO GRANT the Motion for Reconsideration of Lagrimas Construction and Consultancy;
- TO CONSIDER Lagrimas Construction and Consultancy as eligible for the project "Construction of Multi-Purpose Building (Covered Court) at Barangay San Antonio, Quipayo, Calabanga, Camarines Sur", subject to compliance with all other applicable procurement requirements and procedures;

c. TO REQUEST the Procurement Service, Civil Works Division the UNLOCKING of the eligibility processing in the CWA for Contract ID Nos. 25FF0047 - Construction of Multipurpose building (Covered Court) Barangay San Antonio Quipayo Calabanga Camarines Sur
