WHEREAS, the DPWH-Apayao 2nd District Engineering Office advertised the Invitation to Apply for Eligibility and to Bid for **CONTRACT ID 25PC0069: CONVERGENCE AND SPECIAL SUPPORT PROGRAM - SPECIAL ROAD FUND - MOTOR VEHICLE USER'S CHARGE (MVUC) AS PER R.A. 11239 - INSTALLATION/ APPLICATION OF ROAD SAFETY FACILITIES (ROADWAY LIGHTING) ALONG KABUGAO-PUDTOL-LUNA-CAGAYAN BDRY RD - K0669 + 850- K0679+070** in the DPWH Website on June 11 – June 18, 2025, PhilGEPS and in a conspicuous place at the premises of the DPWH-Apayao 2nd District Engineering Office on June 11– July 1, 2025;

WHEREAS, the advertised Approved Budget for the Contract (ABC) is ₱ 34,300,000.00;

WHEREAS, in response to the said Invitation, the BAC received one (1) bid for the Contract;

WHEREAS, on **July 1, 2025**, the BAC conducted the Eligibility Check and found ONE (1) bidder eligible;

WHEREAS, on **July 1, 2025 at 2:00 P.M.**, the BAC convened and opened the bid of the eligible bidder;

WHEREAS, of the bid from the eligible bidder, one (1) bid passed the preliminary examination by the BAC of the Technical and Financial Proposals based on the presence of the submitted documents as against the checklist of required documents, and, consequently, the BAC read and recorded their bid;

WHEREAS, the BAC, with the assistance of its Technical Working Group, conducted the detailed evaluation of the abovementioned bid on July 4, 2025:

WHEREAS, upon the conduct of detailed bid evaluation, the BAC found a variance between the bid price as read during the opening of bids and the bid price as calculated based on the submitted financial documents of the bidder. The bid as calculated was determined to exceed the Approved Budget for the Contract (ABC). As stated in Section 31.1 of the 2016 Revised IRR of RA 9184, *"If a bid price, as evaluated and calculated in accordance with this IRR, is higher than the ABC, the bidder submitting the same shall be automatically **disqualified**".*

WHEREAS, Section 35.1(c) of the 2016 Revised IRR of RA 9184 provides that the BAC shall declare a failure of bidding when all bids fail to comply with all the bid requirements.
