**REQUEST FOR EXPRESSION OF INTEREST (REI)**

**24CSDE01 – Consulting Services for the Detailed Engineering Design including Topographic Survey, Hydrographic Survey, Design Analyses and Geotechnical Investigation of Various Bridges, Flood Control and Building Projects under Batangas II District Engineering Office**

1. The **Department of Public Works and Highways (DPWH), Batangas II District Engineering Office**, through the General Appropriations Act (GAA) FY 2024 intends to apply the sum of **Three Million Two Hundred Thirty-One Thousand Nine Hundred Fifty Three Pesos and Twenty Five Centavos Only (Php 3,231,953.25)** being the Approved Budget for the Contract (ABC) to payments under the contract for **24CSDE01 – Consulting Services for the Detailed Engineering Design including Topographic Survey, Hydrographic Survey, Design Analyses and Geotechnical Investigation of Various Bridges, Flood Control and Building Projects under Batangas II District Engineering Office**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The **DPWH Batangas II District Engineering Office** now calls for the submission of eligibility documents for:

Objectives:	<ol style="list-style-type: none"> <li>1. To provide the necessary preliminary detailed engineering design, topographic and hydrographic survey and other design analyses needed to design of proposed bridge and flood control projects.</li> <li>2. To provide geotechnical and geological parameters required for the engineering design and construction of the proposed bridge and flood control projects.</li> <li>3. To prepare the detailed geotechnical analysis and structural design analysis for the multipurpose building projects.</li> <li>4. To gather relevant data that will likely affect the design and construction procedures and activities</li> </ol>

Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **10:00 a.m. on April 24, 2024** at **DPWH Batangas II District Engineering Office, Kumintang Ilaya, Batangas City**. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

3. Interested bidders may obtain further information from **DPWH Batangas II District Engineering Office, Kumintang Ilaya, Batangas City** and inspect the Bidding Documents at the address given on page 3 from 8:00 a.m. to 5:00 p.m.

4. Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
5. The BAC shall draw up the short list of consultants from those who have submitted Expressions of Interest including Eligibility Documents and have been determined as eligible in accordance with the provisions of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act," and its Implementing Rules and Regulations (IRR).

The shortlist shall consist of **three (3)** eligible bidders who will be entitled to submit bids. The criteria and rating system for shortlisting are:

<i>I</i>	<i>Experience of the Firm</i>	60 pts.
<i>II</i>	<i>Availability of the Required Personnel of the Firm</i>	10 pts.
<i>III</i>	<i>Workload</i>	30 pts.
<b>Total</b>		<b>100 pts.</b>

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised IRR of R.A. 9184.

The following persons/entities shall be allowed to participate in the bidding:

- (a) Duly licensed Filipino citizens/sole proprietorships;
  - (b) Partnerships duly organized under the laws of the Philippines and of which at least sixty percent (60%) of the interest belongs to citizens of the Philippines;
  - (c) Corporations duly organized under the laws of the Philippines and of which at least sixty percent (60%) of the outstanding capital stock belongs to citizens of the Philippines;
  - (d) Cooperatives duly organized under the laws of the Philippines; or
  - (e) Persons/entities forming themselves into a joint venture, *i.e.*, a group of two (2) or more persons/entities that intend to be jointly and severally responsible or liable for a particular contract: Provided, however, That Filipino ownership or interest thereof shall be at least sixty percent (60%). For this purpose, Filipino ownership or interest shall be based on the contributions of each of the members of the joint venture as specified in their JVA
7. The Procuring Entity shall evaluate bids using the **Quality Based Evaluation/Selection (QBE/QBS)** procedure. The minimum passing score for the evaluation of the technical proposal is **eighty (80) points**. Only the financial proposal of the bidder with the Highest Rated Bid (HRB) shall be invited for the opening of their financial proposal and evaluated.
8. The contract shall be completed within **Sixty Nine (69) calendar days**.
9. All prospective bidders must present one (1) company ID and one (1) valid government issued ID at the entrance of the office premises.
10. The **DPWH Batangas II District Engineering Office** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with **Sections 35.6 and 41** of the 2016 revised Implementing Rules and Regulations (IRR) of RA 9184, without thereby incurring any liability to the affected bidder or bidders.


