



CONTRACT AGREEMENT

THIS AGREEMENT, made this JUL 08 2025 by and between:

The **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES** through the **DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS-CORDILLERA ADMINISTRATIVE REGION (DPWH-CAR)**, represented by **KHADAFFY D. TANGGOL**, Regional Director, duly authorized for this purpose, with office address at Engineer's Hill, Baguio City, hereinafter called the "**PROCURING ENTITY**,"

and

CERTEZA INFOSYS CORP., a company existing under and by virtue of the laws of the Republic of the Philippines, represented herein by **REYNALDO R.
