DECLARING DISQUALIFICATION OF ALTEO ENGINEERING CONSULTANCY SERVICES AND FHG CONSTRUCTION AND DECLARING A FAILURE IN THE BIDDING FOR CONSULTING SERVICES FOR THE 25CSFK0001- CONSULTANCY SERVICES FOR SUB SOIL INVESTIGATION FY 2025 BRIDGES AND BUILDING PROJECTS, SORSOGON 1ST DEO

WHEREAS, the Department of Public Works and Highways (DPWH), thru this Procuring Entity, is procuring the abovementioned Contract using the Quality-Cost Based Evaluation (QCBE) system in accordance with the provisions of Republic Act (RA) No. 9184 and its Implementing Rules and Regulations (IRR);

WHEREAS, in response to the Request for Expression of Interest (REOI) advertised/posted by this Bids and Awards Committee:

- a. Two (2) consultants submitted their Expressions of Interest (EOI) and Eligibility Documents.
- b. Of the latter, Two (2) consultants were found eligible by the Bids and Awards Committee (BAC).
- c. Of the latter, Two (2) consultants submitted bids.
- d. Of the latter, no consultant submitted complying bids.

WHEREAS, in accordance with Section 35 of RA 9184-IRR, considering the above circumstances, there is a failure in the bidding for this contract on the following ground:

- d. Of the Two (2) consultant that submitted bids, **ALTEO ENGINEERING CONSULTANCY SERVICES** was found non-responsive due to the submitted curriculum vitae of each proposed professional staff was not originally signed and was not notarized and **FHG CONSTRUCTION** submitted an expired Mayor's Permit on the 3rd page of their PhilGEPS Certificate

WHEREAS, in accordance with requirement in the Philippine Bidding Documents Section II Eligibility Documents 3. Format and Signing of Eligibility Documents 3.2 Prospective bidders shall prepare an original and copies of the eligibility documents. In the event of any discrepancy between the original and the copies, the original shall prevail. Moreover, in accordance to 4. Consultant's Responsibilities. (f) Ensuring that each of the documents submitted in satisfaction of the bidding requirements is an authentic copy of the original, complete, and all statements and information provided therein are true and correct.

WHEREAS, in accordance to the revised 2016 IRR of R.A. 9184 section 24.4.3 To facilitate determination of eligibility, the BAC of a Procuring Entity shall use the contents of the PhilGEPS electronic registry of manufacturers, suppliers, distributors, contractors, and/or consultants, in accordance with Section 8.5.2 of this IRR.

WHEREAS, in accordance to the revised 2016 IRR of R.A. 9184 section 23.6 Notwithstanding the eligibility of a bidder, the Procuring Entity concerned reserves the right to review the qualifications of the bidder at any stage of the procurement process if the Procuring Entity has reasonable grounds to believe that a misrepresentation has been made by the said bidder, or that there has been a change in the bidder's capability to undertake the project from the time it submitted its eligibility requirements. Should such review uncover any misrepresentation made in the eligibility requirements, statements or documents, or any changes in the situation of the bidder which will affect the capability of the bidder to undertake the project so that it fails the eligibility criteria, the Procuring Entity shall consider the said bidder as ineligible and shall disqualify it from obtaining an award or contract, in accordance with Rules XXI, XXII, and XXIII of this IRR

NOW, THEREFORE, We, the Members of the Bids and Awards Committee (BAC), hereby RESOLVE:

- a. To disqualify ALTEO ENGINEERING CONSULTANCY SERVICES and FHG CONSTRUCTION
- b. to declare the Bidding for the 25CSFK0001- CONSULTANCY SERVICES FOR SUB SOIL INVESTIGATION FY 2025 BRIDGES AND BUILDING PROJECTS, SORSOGON 1ST DEO a failure; and
- c. to recommend approval by the District Engineer of the said declaration by the BAC of the disqualification and failure of the Bidding for the 25CSFK0001- CONSULTANCY SERVICES FOR SUB SOIL INVESTIGATION FY 2025 BRIDGES AND BUILDING PROJECTS, SORSOGON 1ST DEO
