WHEREAS, the Department of Public Works and Highways – Iligan City District Engineering Office thru its Bids and Awards Committee posted the Invitation to Bid for the Contract ID No. 24CKM0001 – Real Property Appraisal Services for Properties Affected by the Project "Paving of Unpaved Roads along Lanao Del Norte Interior Circum. WHEREAS, Section 41c of the Revised Implementing Rules and Regulations of R.A. 9184 – The Head of the Agency reserves the right to reject any and all Bids, declare a failure of bidding, or not award the contract in the following situations: (a) will not redound to the benefit of the GoP, as follows: (i) if the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the HoPE; (ii) if the project is no longer necessary as determined by the HoPE; or (iii) if the source of funds for the project has been withheld or reduced through no fault of the Procuring Entity.
