**WHEREAS**, during the Pre-Procurement Conference on **April 25, 2025**, this Bids and Award Committee (BAC) for Consulting Services approved the recommendation of the **Planning and Design Section** to adopt the Quality-Cost Based Evaluation (QCBE) procedure for this procurement;

**WHEREAS**, in response to the RFP, One (1)-Consultant submitted his Expression of Interest (EOI) together with his Eligibility and Technical Proposal;

**WHEREAS**, during the opening of bids on **May 8, 2025**, **C.H. BEATISULA ENGINEERING CONSULTANCY** passed the preliminary examination of bids:

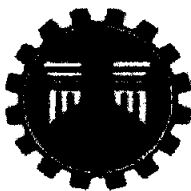




