The **DPWH-Isabela 3rd District Engineering Office**, through **Engineering & Administrative Overhead CY 2024 - FY 2024 RA 11975 REGULAR 2024 CURRENT** intends to apply the sum of **₱ 3,045,607.95** being the Approved Budget for the Contract (ABC) to payments under the **Contract ID 24GBG21: Furnishing and Delivery of Construction Materials for the repair of drainage to address ponding of rainwater along Daang Maharlika-Alicia, DPWH- Isabela Third District Engineering Office, Brgy. Tagaran, Cauayan City, Isabela**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **DPWH-Isabela 3rd District Engineering Office** through its Bids and Awards Committee now invites bids for the above Procurement Project. Completion of the Works is required within the supply period until **January 2025**.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

To be eligible to bid for this contract, a contractor must meet the following major requirements:

- a. Registration certificate from SEC, Department of Trade and Industry (DTI) for sole proprietorship, or CDA for cooperatives;
 - b. Filipino citizen or 60% Filipino-owned partnership/corporation;
 - c. Valid PhilGEPS Registration Certificate (Platinum Membership) (all pages) in accordance with Section 8.5.2 of the IRR;
 - d. Completion of similar contract costing at least 50% of ABC;
 - e. Net Financial Contracting Capacity (NFCC) at least equal to the ABC.
4. Prospective bidders may obtain further information from **DPWH-Isabela Third District Engineering Office** and inspect the Bidding Documents at the **BAC Secretariat, Procurement Unit Office, DPWH-Isabela Third District Engineering Office, Tagaran, Cauayan City, Isabela** during weekdays from **8:00 A.M. to 5:00 P.M.**

A complete set of Bidding Documents may be acquired by interested bidders on **November 28, 2024 to December 18, 2024** (8:00 A.M. – 5:00 P.M.) and **December 19, 2024** until 9:00 A.M. at **BAC Secretariat, Procurement Unit Office, DPWH-Isabela Third District Engineering Office, Tagaran, Cauayan City, Isabela** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **PHP 5,000.00**.

The DPWH-Isabela Third District Engineering Office will hold a Pre-Bid Conference on **December 05, 2024 at 9:00 A.M.** at **New Conference Room, DPWH-Isabela Third District Engineering Office, Tagaran, Cauayan City, Isabela** through live streaming on Youtube: <https://www.youtube.com/@DPWHIsabela3rdDEO> which shall be open to prospective bidders or bidder's representatives who chose to attend the activity, subject to existing health protocol.
7. Bids must be duly received by the BAC Secretariat through (a) manual submission at the office address indicated below, or (b) online or electronic submission as indicated below, or (c) both on or before **December 19, 2024**. Late bids shall not be accepted
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **Instruction To Bidders (ITB) Clause 14**.

Bid opening shall be on **December 19, 2024, immediately after the deadline of submission of bids**, at **New Conference Room, DPWH-Isabela Third District Engineering Office, Tagaran, Cauayan City, and Isabela** and/or through live streaming on Youtube: <https://www.youtube.com/@DPWHIsabela3rdDEO> which shall be open to prospective bidders or bidder's representatives who chose to attend the activity, subject to existing health protocol.

The Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), and the website of Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
