



INVITATION TO BID FOR

24GBJ16 – Provision of Minor Basic Highway Maintenance Equipment and tools for use in the repair/maintenance of various national roads and bridges along Nueva Vizcaya 2nd DEO jurisdiction under Work Categories 18: Traffic Service Maintenance and 10: Pavement Maintenance

- 1. Activity No. 302 : Centerline and Lane Line Repainting – Repainting of centerline and lane lines**
- 2. Activity No. 309 : Other Traffic Services – Repainting of edgeline, pedestrian crosswalk, stoplines, and pavement messages**
- 3. Activity No. 503: Indirect Cost Work Expenses – Repair and replacement of hand tools**

1. The **DPWH-Nueva Vizcaya 2nd District Engineering Office**, through the **GAA FY 2024** intends to apply the sum of **₱2,661,680.00** being the Approved Budget for the Contract (ABC) to payments under the contract for **24GBJ16 – Provision of Minor Basic Highway Maintenance Equipment and tools for use in the repair/maintenance of various national roads and bridges along Nueva Vizcaya 2nd DEO jurisdiction under Work Categories 18: Traffic Service Maintenance and 10: Pavement Maintenance**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **DPWH-Nueva Vizcaya 2nd District Engineering Office** now invites bids for the above Procurement of Goods. Contract duration of Services/Goods is required **seven (7) Calendar Days**. Bidder should have completed, within **Five (5) Years** from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. (Instruction to bidders)
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.p

4. Prospective bidders may obtain further information from **Department of Public Works and Highways-Nueva Vizcaya 2nd District Engineering Office**, and inspect the Bidding Documents at the address given below **from 8:00 am to 5:00 pm (Mondays to Fridays)**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 29, 2024 to December 19, 2024** from the given address and website(s) below, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five**

Thousand Pesos only (P 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The **DPWH-Nueva Vizcaya 2nd District Engineering Office** will hold a Pre-Bid Conference on **December 6, 2024 (9:00 AM)** at **Conference Room, DPWH 2nd DEO, Malasin, Dupax del Norte, Nueva Vizcaya**, and/or through webcasting via Youtube Channel **(DPWH Nueva Vizcaya 2nd DEO Procurement Livestream)** which shall be open to all interested parties. Interested parties are encouraged to send their representative to attend the Pre-Bid Conference.
7. Bids must be duly received by the BAC Secretariat for manual submission at the **Conference Room, DPWH Nueva Vizcaya 2nd District Engineering Office, Malasin, Dupax del Norte, Nueva Vizcaya** on or before **9:00am of December 19, 2024.** Late bids shall not be accepted.
8. All bid must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **December 19, 2024 at 9:00am** at the **Conference Room, DPWH Nueva Vizcaya 2nd District Engineering Office, Malasin, Dupax del Norte, Nueva Vizcaya**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted
10. The **DPWH Nueva Vizcaya 2nd District Engineering Office** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
