The **DPWH-Tarlac 1st District Engineering Office** through the **FY 2024 Unprogrammed Funds** intends to apply the sum of <u>as stated above</u> being the ABC to payments under the contract for <u>above-named procurement.</u> Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DPWH-Tarlac 1st District Engineering Office now invites bids for the above Procurement Project. Delivery of the Goods is required by 120 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from **DPWH-Tarlac 1st District Engineering Office** and inspect the Bidding Documents at the address given below during **8:00 A.M. to 5:00 P.M. Monday to Friday**.
- 5. A complete set of Bidding Documents may be acquired by interested bidders from the given address and website/s <u>as stated below</u> and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount **as stated above**.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on *February 3, 2025* at 10:00 A.M. at Conference Room, DPWH-Tarlac 1st DEO and/through live stream on Youtube: https://youtube.com/@DPWH.Tarlac1DEO. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
