WHEREAS, on the same date upon the bid evaluation from the technical working group for St. Joseph Construction & Trading it was found out that it was above ABC, in accordance to the Revised Implementing Rules and Regulations (IRR) of R.A. 9184 Section 33 that stated "In case any of the requirements in the second envelope of a particular bid is missing, incomplete or patently insufficient, and/or if the submitted total bid price exceeds the ABC, the BAC shall rate the bid concerned as **"failed"**;


WHEREAS, the ABSTRACT OF QUOTATIONS showed that among the suppliers who submitted their quotations, only **MJ2 HARDWARE & CONSTRUCTION SUPPLIES** complied with and was found responsive to the requirements under the Request for Quotation (RFQ) with the lowest calculated responsive bid, with items (goods) specifications acceptable to the Implementing Office/End-User Unit Concerned;


NOW THEREFORE, We, the members of the Bids and Awards Committee (BAC) for Goods resolves as it is hereby resolved to recommend the award of the contract for the procurement of said goods through Small Value Procurement in the total amount of **(P 984,689.25) (NINE HUNDRED EIGHTY-FOUR THOUSAND SIX HUNDRED EIGHTY-NINE PESOS AND 25/100)** to **MJ2 HARDWARE & CONSTRUCTION SUPPLIES** which submitted the lowest calculated bid.
