The **DPWH-Tarlac 1st District Engineering Office** through the **FY 2025 GAA Fund** and **FY 2025 GAA Fund (Routine)** intends to apply the sum of <u>as stated</u> **above** being the ABC to payments under the contract for <u>above-named</u> **procurement.** Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **DPWH-Tarlac 1st District Engineering Office** now invites bids for the above Procurement Project. Delivery of the Goods is required by **Staggered basis six (6) months or more**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from **DPWH-Tarlac 1st District Engineering Office** and inspect the Bidding Documents at the address given below during **8:00 A.M. to 5:00 P.M. Monday to Friday**.
- 5. A complete set of Bidding Documents may be acquired by interested bidders from the given address and website/s **as stated below** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount **as stated above**.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
