Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Act". The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who has determined as such during post-qualification.
- V. Prospective bidders may obtain further information from DPWH – Bulacan 2ND District Engineering Office and inspect the bidding Documents at the Office of the BAC Secretariat, DPWH-Bulacan 2ND DEO, Pulong Buhangin, Sta. Maria, Bulacan during weekdays from 8:00am to 5:00 pm
- V. A complete set of Bidding Documents may be acquired by interested bidders on May 10, 2024 to May 30, 2024 from the given address, website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount Stated Above. - VII. Bids must be duly received by the BAC Secretariat at the address below for manual submission. Late bids shall not be accepted. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- VIII. Bid opening shall be on May 28, 2024 right after the deadline for the submission of bids at the Conference Room, Bulacan 2nd District Engineering Office, Pulong Buhangin, Sta. Maria, Bulacan and through live-streamed on YouTube: https://www.youtube.com/@Bulacan_2nd_DEO Bids will be opened in the presence of the bidder's representatives who choose to attend at the above address or on live-streamed. Late bids shall not be accepted.
- IX. If at the time of post-qualification procedure, the BAC verifies that any of the deficiencies is due to the contractor's fault or negligence pursuant to 34.3(b)(ii)(c) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184), the Procuring Entity shall disqualify the contractor from the award without any right to reimburse fees and incidental cost paid for the procurement of infrastructure contract subject of the Bid.
- X. The DPWH-Bulacan 2nd District Engineering Office reserves the right to reject any or all bids, declare a failure of bidding or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 Revised IRR of R.A. No. 9184, without thereby incurring any liability to the affected bidder or bidders.
