INVITATION TO BID

1. The Department of Public Works and Highways, Isabela 1st District Engineering Office, City of Ilagan, Isabela through the Engineering and Administrative Overhead CY 2025 intends to apply the sum of **Php6,000,000.00** being the Approved budget for the Contract to payment under the contract for:

25GBE02: SUPPLY AND DELIVERY OF 2-UNITS BRAND NEW STAKE TRUCK WITH DROP SIDE CARGO BODY

Bids received in excess of the individual ABC shall be automatically rejected at bid opening.

- 2. The DPWH Isabela 1st District Engineering Office, City of Ilagan, Isabela now invites bids for the above Procurement Project. **Delivery of the Goods** is required **for Thirty (30) Calendar Days** upon receipt of the Notice to Proceed. Bidders should have completed, within Ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding documents, particularly, in Section II (Instruction to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from DPWH Isabela 1st District Engineering Office, City of Ilagan, Isabela and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM. Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on January 13, 2025 to February 4, 2025 from the given address and website(s) below and upon payment of Php10,000.00 for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees not later that the submission of bids.

- The DPWH Isabela 1st District Engineering Office, City of Ilagan, Isabela will hold a Pre-Bid Conference on January 21, 2025 at 9:00 o'clock AM at the DPWH-IFDEO Conference Hall, and/or through webcasting via Facebook which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 9:00 o'clock AM on February 4, 2025. Late bids shall not be accepted.

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. **Bid Opening** shall be on **February 4**, **2025** immediately after the deadline of submission of Bids at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Department of Public Works and Highways, Isabela 1st District Engineering Office, City of Ilagan, Isabela reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
