



INVITATION TO BID

The Department of Public Works and Highways **Apayao 2nd District Engineering Office**, through its Bids and Awards Committee, through the **FY 2025 GAA** intends to apply the sum of **TWO MILLION TWO HUNDRED TWENTY-ONE THOUSAND NINE HUNDRED SEVENTY-FOUR PESOS ONLY (Php 2,221,974.00)** being the ABC to payments under the contract for **Contract ID No. 25GPC0009- PURCHASE OF FUEL FOR THE USE OF DPWH-ASDEO**.

1. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. **The DPWH-Apayao 2nd District Engineering Office** now invites bids for the above Procurement Project. Delivery of the Goods is required **ONE HUNDRED TWENTY (120) calendar days**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary **"pass/fail"** criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from Department of Public Works and Highways **Apayao 2nd District Engineering Office** and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 PM (Monday-Friday)**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **July 16-August 6, 2025** from the given address or website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE THOUSAND PESOS (Php 5,000.00)**. The procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
