- The Department of Public Works and Highways Regional Office II now invites bids for the DISPOSAL OF VARIOUS UNSERVICEABLE/UNUSABLE MOTOR VEHICLE AND OFFICE EQUIPMENT OF DPWH DPWH REGIONAL OFFICE II AND TEN (10) DISTRICT ENGINEERING OFFICES.
- 3. The above-mentioned properties can be inspected at said location during office hours (8:00 AM to 5:00 PM) Monday to Friday from August 1, 2025 to August 18, 2025.

- 4. Any person, partnership or corporation complying with the prescribed rules and regulations may participate in the bidding. However, members of the Bids and Awards Committee and the Disposal Committee and their relatives within the fourth civil degree of consanguinity or affinity are not allowed to participate.
- 5. Invitation to Bid and Proposal Forms can be secured at the Office of the Secretariat, DPWH Regional Disposal Committee, in the Supply and Property Management Section Administrative Division, Regional Office II, Regional Government Center, Tuguegarao City, Cagayan from 8:00 AM to 5:00 PM on August 1, 2025 to August 18, 2025. A non-refundable fee in the amount of Five Thousand Pesos (Php 5,000.00) to defray the cost of reproducing the required documents and publications shall be paid to the Cash Section.
- 6. Only duly authorized representatives who are properly identified with two (2) valid IDs: a company ID and any government-issued ID, are allowed to purchase bidding documents.
- 7. Interested bidders shall submit their bids in two (2) separate envelopes enclosed in a mother envelope. The mother envelope must be sealed and marked on the face with the name and address of the bidder, the Invitation Number and the date and hour of opening, and shall be submitted during the bidding.

The first envelope shall contain the bid bond and shall be marked "BID BOND", while the second envelope shall contain the bid form which contains the bid offer and shall be marked "BID OFFER".

- 8. The bid bond should be at least 10% of the minimum GMSP while the bid offer must not be less than the GMSP. The bid bond and/or bid offer shall be in the form of cash, manager's check, or cashier's check acquired from a reputable bank within the area where bidding is to be held, and shall be submitted to the Chairperson, Regional Disposal Committee, Regional Government Center, DPWH Regional Office II, Tuguegarao City, Cagayan, not later than 10:00 AM on August 19, 2025.
- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion. Bid opening shall be on August 19, 2025, 10:00 AM at the Procurement Conference Room, 4th floor, New Extension Building, DPWH RO II.
- 10. The Department of Public Works and Highways reserves the right to reject any or all bids, waive any defect contained therein and accept the offer most advantageous to the government.
