 The DPWH – Cebu City District Engineering Office, through its Bids and Awards Committee (BAC), is inviting interested consultants to apply for eligibility and shortlisting and, if found eligible and shortlisted, to bid for the Geotechnical Investigation of hereunder Infrastructure Projects:

Preliminary Engineering / Detailed Engineering (PE / DE) of Various DPWH Projects, Cebu City

2. The **DPWH- Cebu City District Engineering Office** now calls for the submission of eligibility documents for **Preliminary Engineering / Detailed Engineering (PE / DE)**. Interested consultants must submit their Eligibility Documents at **Procurement Unit, Cebu City District Engineering Office, V. Sotto St., Brgy. Tinago, Cebu City**. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

3. The BAC shall draw up the short list of consultants from those who have submitted *Expressions of Interest and Eligibility Documents* and have been determined as eligible in accordance with the provisions of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act," and its Implementing Rules and Regulations (IRR). The short list shall consist of **at least two (2)** prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

- **3.1 Experience of the firm** (Refer to D.O. No. 005, S. 2021) ------ 50%
- 3.2 Availability of Required (Refer to D.O. No. 005, S. 2021) ------ 20% Personnel of the Firm
- **3.3 Workload** (Refer to D.O. No. 005, S. 2021) ------ 30%

4. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the IRR of RA 9184. In addition, Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

5. The Procuring Entity shall evaluate bids using the **Quality-Cost Based Evaluation/Selection** (**QCBE/QCBS**) procedure. The Technical and Financial Proposals shall have weights of **65% and 35%**, respectively. The criteria and rating system for the evaluation of bids are provided in the Instructions to Bidders.

6. The **DPWH Cebu City District Engineering Office** reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
