2. Delivery Period within **25 CD** upon receipt of the approved funded Purchase Order, PO, Administrative penalties pursuant to Sec.69 of the Revised IRR-RA 9184 shall be imposed for non-delivery without valid reason.
3. Price validity shall be for a period of sixty calendar days.
4. G-EPS Registration Certification/Mayor's Permit or Business Permit/DTI shall be attached upon submission of the quotation.
5. Bidders shall submit duly signed Omnibus Sworn Statement.
6. The Approved budget ceiling for this procurement is **P285,933.16**
7. All documents must be in A4 size Bond Paper.
8. Supplier must have **NO PENDING** delivery in the district and other district offices.
9. Product should meet the Bureau of Fire Protection (BFP) Standards.
10. Bidder must have local office and physical store for checking of product.
11. Supplier should guarantee that the supplied items are free from defects and agrees to remedy any defects or furnish a new item in exchange for any item supplied which use and service discloses such defect, provided that the materials are examined by the factory or authorized agent.
