REQUEST FOR EXPRESSION OF INTEREST (REOI)

FUEL REQUIREMENT OF DPWH-QUEZON CITY SECOND DISTRICT ENGINEERING OFFICE (DPWH-QCSDEO)

The Department of Public Works and Highways – **QUEZON CITY SECOND DISTRICT ENGINEERING OFFICE**, through the GAA FY 2025 (AMWP) intends to apply the sum of **Three Million Pesos (Php 3,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for Contract I.D. No: **25-OG-004(G)**, with Contract Name: **Fuel Requirement of DPWH-Quezon City Second District Engineering Office (DPWH-QCSDEO)**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.

The Department of Public Works and Highways – **QUEZON CITY SECOND DISTRICT ENGINEERING OFFICE** now calls for the submission of eligibility documents for The Project: **Fuel Requirement of DPWH-Quezon City Second District Engineering Office (DPWH-QCSDEO)**. Eligibility documents of interested Supplier must be duly received by the BAC Secretariat on or before **June 30, 2025**, 10:00 A.M. at BAC, DPWH-QCSDEO, 790 EDSA, Diliman, Quezon City. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

Interested bidders may obtain further information from Jan Peter M. Bautista, BAC Secretariat Head and inspect the Bidding Documents at the BAC, DPWH-QCSDEO, 790 EDSA, Diliman, Quezon City from 7:00 A.M. to 4:00 PM

Pre-bid conference will be on **June 18, 2025**, 2:00 P.M. at the DPWH-QCSDEO Conference Room, 790 EDSA, Diliman, Quezon City.

A complete set of Bidding Documents may be acquired by interested Bidders starting June 11, 2025 to June 30, 2025, from 7:00 A.M. to 4:00 PM, on the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The BAC shall draw up the short list of Suppliers from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR).

The short list shall consist of prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

The BAC is conducting the public bidding for this Contract in accordance with RA 9184 and its Implementing Rules and Regulations.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.

The contract shall be completed within Thirty (30) Calendar Days.

Opening of Bids will be on **June 30, 2025**, at the DPWH-QCSDEO Conference Room, 790 EDSA, Diliman, Quezon City.

The Department of Public Works and Highways – **QUEZON CITY SECOND DISTRICT ENGINEERING OFFICE** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
