WHEREAS, the DPWH Davao Oriental First District Engineering Office posted on **June 18, 2025** the INVITATION TO BID for Contract ID. 25GLF0040 – Supply and deliver of diesel fuel for use in the service vehicles and equipment in connection with the supervision of various projects and financial transaction of the DPWH first DEO, Baganga, Davao Oriental CY-2025, with an Approved Budget for the Contract (ABC) of **Php1,328,800.00** in the DPWH Website, the PhilGEPS, and conspicuous place in the premises of the DPWH continuously for seven (7) days;

WHEREAS, the Invitation to Bid must be submitted on or before 10:00 A.M. on **July 2, 2025** at the Office of BAC Chairperson, DPWH Baganga, Davao Oriental and subsequently bids must be opened at 10:15 A.M. on the same day;

WHEREAS, during the Submission and Opening of Bids on **July 2, 2025**, **no bids were received** by the BAC;

WHEREAS, pursuant to Section 35.1(a) of the IRR of RA 9184, the BAC shall declare the bidding a failure when no Bids are received;

NOW THEREFORE, the herein Bids and Awards Committee (BAC) resolves as it is hereby resolved to declare a failure of bidding for Contract ID. 25GLF0040 – Supply and deliver of diesel fuel for use in the service vehicles and equipment in connection with the supervision of various projects and financial transaction of the DPWH first DEO, Baganga, Davao Oriental CY-2025 due to non-receipt of bids and further recommends a Re-Advertisement with Re-Bidding.
