## RESOLUTION ON THE CANCELLATION OF PROCUREMENT PROCESS OF PURCHASE REQUEST NUMBER (P.R NO.) 2025-07-0085-A OFFICE SUPPLIES TO BE USED @ VARIOUS SECTIONS OF DPWH CEBU 2<sup>nd</sup> DEO

WHEREAS, on June 30, 2025 the Department of Public Works and Highways (DPWH) – Cebu 2<sup>nd</sup> District Engineering Office inquired online through PS-DBM regarding the availability of commonuse supplies and equipment.

WHEREAS, in response to the said confirmation, the Department of Public Works and Highways (DPWH) – Cebu 2<sup>nd</sup> District Engineering Office initiated the Procurement of Office Supplies to be used in various sections of the DPWH Cebu 2<sup>nd</sup> DEO through P.R No. 2025-07-0085-A dated July 1, 2025, amounting to Thirty-One Thousand Six Hundred Thirty-Five Pesos and 57/100 only (P31,635.57), supported by an OBR (Obligation Request) and CAF (Certification of Availability of Funds).

**WHEREAS,** upon the preparation of the said OBR and CAF on July 9, 2025, the DPWH Cebu 2<sup>nd</sup> DEO reaffirmed the availability of the said office supplies with PS-DBM. However, the PS-DBM replied that two items in the list were no longer available.

WHEREAS, due to the unavailability of the items, the aforementioned Purchase Request (P.R), along with the corresponding Updated Project Procurement Management Plan (UPPMP), is hereby cancelled. Consequently, the amount of (₱31,635.57) shall be deducted from the category of Office Supplies in the Updated Annual Procurement Plan (UAPP), and all related procurement contents shall be disbanded.

**RESOLVED FURTHER,** the Bids and Awards Committee (BAC) hereby resolves to terminate all DoTS transactions related to the above-mentioned purchase request.
