- anticipated flat terrain for the entire alignment.
- Inclusion of necessary miscellaneous structures to make the road safe to travel for both motorists and pedestrians such as 417 l.m. Metal Guardrail(Metal Beam) including Post, 10 Metal Beam End Piece, 3 Warning Signs, 33 Hazard Markers (Chevron Signs) and 334.41 sq.m. Reflectorized Thermoplastic Pavement Markings which constitutes 14.08% of the total project cost.

Based on our evaluation, the submitted request for modification of the said project is in order hence, it is respectfully recommended to the Secretary for his consideration and approval.
