## Justification:

Increase in physical target from 0.588 lane-km to **1.200** lane-km and modification of project limit due to the following: The design of the road does not require corrections on vertical alignments of the road since it runs along a

- very flat terrain; Modified original limits from K1510 + 401 - K1510 + 791 (R/S) to K1509+860 - K1509+933, K1510 + . 290 - K1510 + 410 to cover adjacent sections of the road which has urgent need for road widening and improvement of drainage system especially the project is located in a highly urbanized area; and
- Extension/inclusion of additional section that needs widening and improvement of drainage going to outfall for the limits K1509+860 - K1509+933, K1510 + 290 - K1510 + 410 to decongest since it is identified as bottle neck area.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
