Justification:

Original work (construction of concrete road) was replaced with construction of gravel road (including change in physical target) due to:

- As per actual survey, there is an existing river crossing along the project alignment, hence, the need to
 prioritize the bridge. The needed bridge as per design is 100 lm which requires almost half of the allocation
 for road concreting, thus, allocation and type of road was reduced and replaced; and
- The road runs on a mountainous terrain (mostly rippable) which traverses ridge and cliff sections especially that said road is a new road/missing gap. Some portions of the road are very narrow with trail sections (width of 2-4 m). Because of this, there is a need to open/downgrade the road especially along the ridge sections (about a cut ranging from 3-9 meters) and offset the horizontal alignment especially along steep cliff sections (ranging from 3 up to 11 m) to conform with the DPWH Design Guidelines and Standards (Horizontal and Vertical Alignment and Road Width). As such, the need for considerable amount for said opening/improvement/gravelling. Said major changes in the vertical and horizontal alignments require voluminous excavation. Road design requires high side cuts also on some portions of the road (ranging from 12-15 meters). With said earthworks requirement which require considerable cost, the reduced allocation for the road could not cover the concreting of the road especially that the distance from the end of project limits of the contiguous project under 2018 (package 2) to the proposed bridge is about to 2.9 km. Hence, the need to prioritize the opening/improvement of the road up to the bridge to make the road passable and at the same time safe for the travelling public.

Based on our evaluation, the herein request is found in order, hence approval is hereby recommended.
