| 1 | Justification: Increase in physical target (from 143 sq.m. to 248.80 sq.m.) due to the following: Length of the bridge as per actual need/designed is 40 ln.m. instead of anticipated 14 ln.m. The number of lanes to be constructed is only 1 lane instead of 2 lanes inorder to complete the construction of the bridge for it to be functional since it requires considerable length | | | | | | |

The length of the Reinforced Concrete piles to be driven is only 10 ln.m. instead of the anticipated 15 ln.m., hence lower unit cost.

Based on our evaluation, the herein request is found in order, hence approval is hereby recommended.
