Justification:

- As per actual survey, the need for the Construction of Concrete Road is only 0.278 lane km instead of 1.130 lane km, hence, decrease in physical target were modified with the minimum pavement requirements;
- Additional component CW-3 with physical target of 1.722 lane km, since the existing asphalt pavement is already dilapidated and it is necessary to reconstruct into concrete pavement with inclusion of roadside features and provision of pavement markings; and
- Decrease in component cost and physical targets for CW-2 Construction of Drainage Structure since the remaining length for drainage structures to connect/contiguous with FY 2016 Project is only 406 Im instead of 1,340 Im.

Based on our evaluation, the herein request is found in order, hence approval is hereby recommended.
