Increase in physical target from 15.308 lane km to 21.798 lane km due to the following:

- There are portions of the road that run on flat terrain instead of the anticipated mountainous terrain for the entire stretch;
 - There is minimal correction on the horizontal alignment of the road, hence, with lesser side cuts (average of 2 m instead of the anticipated 6 m);
 - The actual terrain requires lesser excavation for some portions of the road with an average cut of 3 m instead of the anticipated 5 m, hence, lower unit cost.
