Justification:

Decrease in physical target for CW1-Construction of Road Slope Protection Structure from 303.98 square meters to 179.00 square meters with modification in station limits from "K1522 + 572 - K1522 + 586, K1525 + 188 - K1525 + 194, K1525 + 381 - K1525 + 393, K1533 + 387 - K1533 + 397" to "K1525 + 177 - K1525 + 192, K1533 + 378 - K1533 + 388" due to the following:

- Deleted 1st and 3rd sections (K1522 + 572 K1522 + 586 and K1525 + 381 K1525 + 393) and Modified limits for 2nd and 4th sections to prioritize more critical and dangerous sections along the road, which need Immediate measures/interventions to prevent traffic accidents and road closures due to landslides and soil erosion, as validated. In addition, allocation is insufficient to cover all four sections;
- Change in design of the slope protection structure from Concrete Retaining Wall to Gabions with Steel Sheet Piles and Grouted Riprap Slope Protection. Hence, higher unit cost, correspondingly, decrease in physical target;
- For section 1, the appropriate design is Gabions (1m x 1m x 2m) with 264.00 cubic meters having a height of 6.00 meters including Z-Type Hot Rolled Steel Sheet Piles (3m embedded depth) with a total length of 15 in.m.;
- For section 2, it includes construction of grouted riprap slope protection having an average slant height of 3.5 m with a total length of 10 In.m. inorder to prevent scouring/landslide at the cliff side of the road;
- Project also involves paving of shoulder (2.5m width, 200mm thick) and reblocking (3.35m width, 280mm thick) of damaged
 pavement to provide convenience and safety to the end user; and
- Inclusion of miscellaneous structures such as reflectorized thermoplastic pavement markings for safety of the travelling public.

Attached are the following supporting documents: Approved Program of Work (POW) with Detailed Unit Price Analysis (DUPA), Approved Detailed Engineering Design (DED), Certificate of Reasonableness of Unit Cost, Certificate of Availability of Funds (CAF), Geotagged Photographs, GIS Map, and Annual Infrastructure Program (AIP) based on GAA.
