- The physical target increased from 3.61 lane km. to 5.706 lane km based on actual survey and to widened and extend the unpaved portion of the road and to maximize the utilization of funds.
  - Minimal cost of Earthworks which constitutes 5.43% (₱ 2,616,315.54) of the total project cost, and the road design requires minimal excavation thus, contributed to the decrease in cost per kilometer of the road project.
  - Inclusion of Right of Way Acquisition to compensate property owners of such structures/improvements, fruit bearing trees, coconut trees and crops affected

within the width and station limit of the project for smooth implementation.
This project is in an Island where materials cost is extremely high due to triple handling cost. Aggregate subbase and surface courses are being taken from Cotabato City since the source at Municipality of Sibutu, Tawi-Tawi Province is limited.

Based on our evaluation, the submitted request for project modification is in order, hence approval hereof is recommended.
