### **Justification:**

- The station limits were adjusted to reflect the correct stationing based on the result of actual survey.
- The cost of EARTHWORKS which constituted 6.05% (P2,042,411.68) of the total project cost contributed the increase in component cost such as clearing of obstructions and removal of structures and actual obstructions because the location is a mountainous

terrain where the existing horizontal and vertical alignments do not meet the DPWH Design Guidelines and Criteria.

- Inclusion of Right of Way Acquisition to compensate property owners of such structures/improvements, fruit bearing trees, coconut trees and crops affected within the width and station limit of the project for smooth implementation.
- This project is in an Island where materials cost is extremely high due to triple handling cost. Aggregate subbase and surface courses are being taken from Cotabato City since the source at Municipality of Sapa-sapa, Tawi-Tawi province is limited.

Based on our evaluation, the submitted request for project modification is in order, hence approval hereof is recommended.
