JUSTIFICATION:

Modification is requested to indicate the correct station limits of the project based on actual field requirements. Physical target has decreased based on FY 2017 GAA due to high price of construction materials such as fine aggregate, course aggregate cement and etc. based on price monitoring data submitted by the district offices and the hauling distance to the project site and the inclusion of all design features to conform to D.O.11 series of 2015 resulting that the physical target was decreased from 3.908 lane km to 0.75845 lane km.

Attached are the required documents, such as BP202, Certificate of Availability of Funds (CAF), Program of Works (POW), Evaluation Form (2017 Version 2.1), Certificate of reasonableness, ROCOND Data, Approved Plans and Geotagged photos.
