Decrease in physical target from 2.525 Lane Km to 2.273 Lane Km due to the following:

- The terrain is a combination of flat, rolling and mountainous (mostly mountainous) as per actual site condition instead of the anticipated rolling terrain for the entire stretch;
- The road as per actual terrain requires massive excavation/side cuts (mostly rippable) to conform to the DPWH Design Guidelines and Standards (Horizontal and Vertical Alignment and Road Width).
