The change in scope of work from "Construction of Concrete Road" to "Construction of Concrete Bridge" is necessary in order to facilitate the mobility of the equipment in the succeeding projects within road section. The derived physical target of 1,144.80 sq.m. (120 LM x 9.54 LM) is in conformity with the bridge standard See attached RD Certificate of Reasonableness of Unit Cost/Justification.
