Justification:

• Movement of funds between project components to allocate funds for the additional civil works.

- "CW2: Construction of Drainage Structure along Road" to drain surface water away from roadway during heavy rains to keep the road safe for motorist and pedestrians.
- "CW3: Construction of Road Slope Protection Structure" to improve stability and resistance to run-off protecting the road from sliding, scouring and erosion of soil.
- "CW4: ROW Acquisition" to allocate funds for the removal of structures for affected private properties.

- Decrease in unit cost for CW1 to apportion funds needed for the resulting design structure.
- The derived unit cost and physical target were based on the approved plans, POW, DUPA, and CMPD.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
