 The station limits were adjusted to reflect the correct stationing based on the result of actual survey and to replace the deteriorated/weak bridge.

 Minimal cost of Earthworks for approaches which constitutes 8.56% (₱1,169,508.86) of the total project cost, thus, contributed to the decrease in cost per kilometer of the road project.

• The road design includes drainage and slope protections structures to address surface runoff and Slope Protection Structures to prevent the road embankment from scouring/erosion constituting to 19.59% (₱2,675,419.80) of the total project cost and it is still conform within the prevailing cost of the Department.



This project is located in an Island where materials cost is extremely high due to triple handling cost. Aggregate subbase and surface courses are be taken from Cotabato City since the source at Municipality of Jolo, Sulu Province is limited.

Based on our evaluation, the submitted request for project modification is in order, hence approval hereof is recommended.
