## Justification:

- Provision of station limit to determine the exact location and actual length based on the approved Program of Works and DUPA.
- The allocation for Civil Works (CW1) in the GAA exceeds the actual allocation needed for the Construction of Slope Protection, to efficiently utilize the excess amount; the addition of Preventive Maintenance of Road Concrete Reblocking (CW2) was done since this is also necessary within the location of the project.
- This project is located in an Island where materials cost is extremely high due to triple handling cost. Aggregate subbase and surface courses are being taken from Cotabato City since the source in the City of Lamitan, Basilan Province is limited.

Based on our evaluation, the submitted request for project modification is in order, hence approval hereof is recommended.
