- Adjustment of station limit based on actual survey and validation.
- The <u>physical target</u> has <u>decreased</u> from 3.956 lane km to 3.756 lane km <u>due to costing on massive</u> <u>Embankment</u> of common borrow (15.22%), raising the road grade to 1 meter since the road section is a flood prone area.
- Inclusion of all design features to conform with D.O. 11 series of 2015 and the allocation/reserved payment for the Road Right of Way acquisition.
