 Increase in the amount of CW-1 due to inclusion of Miscellaneous Structures such as Reflectorized Thermoplastic Pavement Markings and Concrete Joint Sealant which constitutes 0.82% (₱292,432.13) of the total project cost for center line, edge line and pedestrian line. Inclusion of these item is necessary to provide a safe

and comfortable road to the riding public.

- Inclusion of Right of Way Acquisition to compensate property owners of such structures/improvements, fruit bearing trees, coconut trees and crops affected within the width and station limit of the project for smooth implementation.
- This project is in an Island where materials cost is extremely high due to triple handling cost. Aggregate subbase and surface courses are being taken from Cotabato City since the source at Municipality of Sapa-sapa, Tawi-Tawi province is limited.

Based on our evaluation, the submitted request for project modification is in order, hence approval hereof is recommended.
