Slight decrease in physical target based on approved POW and DUPA by 0.076 lane km. due to the increase in pavement thickness from 0.28 meter into 0.30 meter and inclusion of Reflectorized Thermoplastic Pavement Markings.

• Road Reconstruction in station K1274 + 800 - K1275 + 157 is at inner lanes only (2 lanes) excluding the outer lanes.

 The additional stations K1275 + 157 - K1275 + 480 (326 l.m.) at inner lanes include the stations which have poor surface condition based on RBIA report.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
