Justification:

- Change in station limit to prioritize segment with major wearing surface along the road section is due to conflict with the on-going construction of flyover implemented by Regional Office within the intersection of Roman Expressway and the original station (See Vicinity Map 1).
- Decrease in Physical Target and increase in Unit Cost for Project Component CW-1 due lengthen of station limit and approved POW and Plan.
