Justification:

- Change in station limits due to overlapping with FY 2018 Project (P00202494LZ). The project was modified to K0064+236 – K0064+410 to have continuity with P00202494LZ.
- K0067+425 K0068+075, K0068+155 K0069+730, and K0069+781 K0070+330 were included because these stations need drainage structures to contain and drain flood waters during rainy
- The released allocation is sufficient to cover the increase in physical target with reference of the Program of Works (POW) and Detailed Unit Price Analysis (DUPA) for which prevailing price of materials were used.

Based on our evaluation, the submitted request for modification of the said project is in order. Hence, the said request is hereby recommended for Secretary's consideration and approval.
