JUSTIFICATION:

The physical target is shortened due to the actual design of bridge. The pier is a composite pile with length of RC Pile ranging from 16m to 21m (16.72% of IDC) and the length of H-pile is 16meters (2.14% of IDC). It has a component of steel sheet pile for cofferdamming (7.48% of IDC) with length of 9 meters and provision of craneway (27.02% of IDC). The percentage used in OCM and CP are increased per D.O. # 197, S2016 – Revised Guidelines of New ABC. Thus, the modification is to be made.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Location Map, Certificate of Availability of Funds (CAF) and Geotagged Photos.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
