Justification:

- It was noted that the reflected physical target as per GAA is incorrect. The project allocation of ₱7.00M is not sufficient to complete the construction of concrete road of 3.452 lane km. The project considers the remaining unpaved road of 0.332 lane km within the road section, hence, the decrease in physical target.
- The inclusion of RCBC is necessary in order to accommodate the volume of water coming from a creek that crosses the road, resulting to the increase in unit cost. The estimated cost of the said RCBC comprises 80.41% (₱4,390,059.52) of the total project cost.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
